should be absolutely effervescent with fresh energy, personalities and ideas. The Summit will be at the Colorado Convention Center with great access to all that downtown Denver has to offer.

# **Guidelines for Exhibiting**

# Western Conservative Summit event team will review all exhibit applications. The decisions made by this team are final.

- 1. Appropriate activities in exhibit areas:
  - Interaction with event attendees about your organization/business
  - Distribution of free resources in exhibit area
  - Sale of merchandise
  - Option for attendees to sign up for your mailing list
  - Signatures on petitions **at your exhibit booth** as a voluntary activity with attendees.
  - Initiating verbal contact with passersby from your exhibit booth
  - Animated and respectful discussions
- 2. Inappropriate activities in exhibit area:
  - Initiating contact with passersby from the aisle or other areas adjoining the exhibit area.
  - Walking the aisles and common areas to distribute materials or circulate petitions. *Placing your materials in the general meeting rooms or in any area outside of your booth is not allowed.* For placement in conference packets or at any of the conference sessions, see "Sponsorship" opportunities.
  - Confrontational or loud debates.

3. You will be able to select your own exhibit space when you sign up and pay the registration fee.

4. Freeman Decorating will email a link to an online exhibitor kit and you may make individual choices about your booth space directly with them.

5. No materials may be fastened to the walls of the exhibit hall or concourses without prior

consent of the exhibit team leader or host.

6. Exhibitors may check-in Friday at 11:00 AM at Exhibit Check-in located in the Convention Center to receive exhibitor packet and exhibit space location. You may start set-up immediately after completing check in. Set-up should be completed by 1:00 PM.

7. Western Conservative Summit takes no responsibility for lost or stolen articles.

8. All exhibitors are encouraged to staff their booths during all Summit hours:

Friday, June 26	1:00 PM - 9:30 PM
Saturday, June 27	8:00 AM - 6:45 PM
Sunday, June 28	8:00 AM - 1:00 PM

9. Exhibitors are encouraged to remain until everyone has cleared the venue Sunday afternoon.

10. Audio/visual sound levels in your booth must be kept at a reasonable level as a courtesy to other exhibitors.

11. Exhibitors are expected to maintain proper standards of professionalism at all times. Western Conservative Summit reserves the right to take down or confiscate any material that may be deemed offensive to attendees, venue staff, volunteers, and Western Conservative event staff.

12. Exhibitors are responsible for shipping their materials to and from the event.

#### This process has changed from last year.

Exhibitor may ship directly to the decorator's warehouse (Freeman Decorating) in advance of the show (up to 30 days prior to show move-in - 5/27) or to Colorado Convention Center beginning Thursday prior to the event (6/25). If materials arrive prior to Thursday of event week, the venue may refuse shipments or charge the exhibitor a fee for storage. Exhibitor will be responsible for any storage charges. The decorating company will provide shipping labels via a link on the exhibitor page –plan to use these labels only.

When the freight is received, exhibitor will receive notification that it was received and it will be delivered directly to the exhibit booth during move-in.

Same union restrictions as last year, exhibitors are only allowed to hand carry materials. All other items will be subject to union jurisdiction and handling.

13. Headers will be printed - one –  $7" \ge 44"$  ID sign for each booth. Company name on one line – black copy on white background and this will hang from the back drape of all 8'X 8' booths. The headers will be placed on the skirting of the 6'X 6' table-top booths.

14. Exhibitors are responsible to make their own arrangements for all A/V rentals and outgoing shipments.

15. Exhibitors are responsible to pay their own parking costs. No special arrangements have been made with the venue. The Convention Center parking rates are as follows:

**Parking** - park onsite in their 1,000 space parking garage.

Convention Center parking rates are as follows:

Park up to 8 Hours: \$12.00 Park up to 12 Hours: \$15.00 Park up to 18 Hours: \$17.00 Park up to 24 Hours: \$25.00

### Three FREE Parking Spaces for Hybrid and Electric Cars:

The Colorado Convention Center Parking Garage has designated three reserved parking stalls for Hybrid and Electric Vehicles for up to 8 hours of FREE parking. These free "Green" stalls are offered on a first come first serve basis and when available are located on level P1 in the garage. *Thank you for partnering with the Colorado Convention Center to reduce our impact on the environment and our valuable natural resources.* 

There are public pay lots across the street from the Convention Center as well as pay parking at the Hyatt Regency Denver nearby.

14. Exhibitors are free to explore the exhibit area and public spaces. To participate in the summit sessions requires purchasing a separate registration. Exhibitors receive a significant discount on event registration. The 2015 discounted rate for Exhibitors is 50% off the regular rate for a pass to the Summit. Register for up to 2 special discounted passes at WesternConservativeSummit.com when you register for your exhibit booth. If you are not prepared to register for the conference at that time, you may go back into your exhibit record at a later date to purchase the Summit pass (up to 2).

# **Miscellaneous Information**

# Fire & Safety Information

For the safety of all, exhibitors must comply with all federal, state, and municipal codes that apply to places or buildings of public assembly.

Electrical equipment must be Underwriters Laboratory (UL) approved for their specified use.

Smoking is prohibited in the exhibit area.

All display materials must meet public safety regulations.

Use of flash pots, fireworks, open flame, burning and smoke-emitting materials is prohibited.

Signs and/or decorations may not be taped, nailed, tacked, stapled or otherwise fastened to any wall, ceiling, column, stone, window, or painted surface.

Lights with UL approved clamp-on types of booth spotlights, with porcelain based and metal guards are allowed. **Clip types are not allowed.** 

All exhibit entrances/exits must be clear at all times. No obstructions will be allowed near the entrance/exit areas at any time.

Booth space is limited, available on a first-come-first-served basis and determined by the package purchased:

These are smaller exhibits – 6' x 6' (table tops with no pipe and drape) and are only available by invitation from Centennial Institute. You may receive up to 8 – exhibitor credentials as needed.
